WHAT IS CAMP JOSHUA?

Arkansas Camp Joshua (ACJ) is a three-day camp designed to train high school students to be effective pro-life leaders. It covers all the basics of pro-life issues in classes and hands-on workshops. Not only will you leave the weekend ready to spread the pro-life message, you will also have a blast making new friends, visiting the State Capitol, playing interactive games, enjoying good food, and other activities.

WHO CAN ATTEND AND HOW MUCH?

Arkansas Camp Joshua is typically open to teens 13-19 with some exceptions. ACJ is not a Bible camp or affiliated with any religious denomination. All teens are welcome.
