PLANNED PARENTHOOD SUSPENDS ABORTION SERVICES IN ARKANSAS

On Tuesday, May 29, 2018 the U.S. Supreme Court refused to hear an appeal from Planned Parenthood of Great Plains that had challenged Arkansas Act 577 the Abortion Inducing Drug Safety Act of 2015. The appeal came after the U.S. 8th Circuit Court of Appeals had vacated the injunction imposed by U.S. District Judge Kristine Baker.



As a result Planned Parenthood, who only provides non-surgical abortion, immediately suspended abortion services in both Little Rock and Fayetteville pending court action or compliance with the law.

The 2015 law requires that any physician that performs the medication/medical abortion using the drug cocktail of mifepristone and misoprostol must contract with a physician with hospital privileges to treat serious and potential life threatening complications that may result from the chemical abortion procedure.

Planned Parenthood claims that a toll free 24/7 nurse hotline is sufficient to handle complications and that the inability of Planned Parenthood to find doctors willing to contract with them will put them out of the abortion business in Arkansas. They are appealing to Judge Baker and will undoubtedly continue legal battles to fight this law from taking effect.

It may be temporary... but for now, Planned Parenthood is out of the abortion business in Arkansas!
