95th General Assembly Passes Key Pro-Life Bills

1. **HB 1551/Act 485** - An act to amend the law concerning criminal abortion; to create the offense of coerced criminal abortion by means of fraud; and for other purposes.

2. **HB 1610/Act 387** - An act to amend the Arkansas Human Life Protection Act and the Arkansas Unborn Child Protection Act; to modify the definition of “medical emergency”; and for other purposes.

3. **SB 450/Act 915** - An act to require the Department of Education to include a human fetal growth and development discussion in the relevant standards during the Arkansas academic standards revision cycle; and for other purposes.

4. **SB 591/Act 973** - An act to prohibit race-selection abortion in this state; to create the Race Discrimination by Abortion Prohibition Act; and for other purposes.

Act 310 of 2023 To create a monument to the unborn on the Arkansas State Capitol grounds was signed into law by Governor Sarah Sanders to remember the tragic deaths of unborn children in Arkansas during the 49 years of Roe v. Wade.

This legislation is now a model law for enactment in other states.
