Missouri's laws protected life... **until the state passed Amendment 3 in 2024.**

The sponsors of the extreme pro-abortion amendment told voters that it would end the "*total abortion ban*" but still "*allow regulation of reproductive health care*" and "*allow abortion to be restricted or banned after*" 24 weeks of pregnancy – **these were all half-truths or outright lies.**

The pro-abortion campaign raised and spent **\$31 million** telling Missourians to "Vote Yes" and utterly drowned out the **\$1.3 million** that the pro-life campaign spent warning voters about Amendment 3. Even with the lopsided resources, the pro-abortion amendment narrowly passed with just **51.6% of the vote** on Election Day.

Within 24 hours of the election, supporters of Amendment 3 filed a lawsuit not just to undo what they dubbed the "*total abortion ban*," but to undo almost every legal limit on abortion – even the laws that keep women safe. Here's a list of the laws the pro-abortion extremists tried to wipe away just hours after the polls closed:

- State licensing and regulation of abortion facilities
- The law that only medical doctors perform abortions
- Protections against discriminatory abortions, when a baby is aborted due to their sex, race or a diagnosis of Down syndrome

- Reporting abortions and complications to the state
- The 72-hour waiting period and meeting with the doctor prior to the abortion
- Abortion patients must be seen in person (instead of via telehealth)

This was just their first legal strike at Missouri's law under the new right-to-abortion. At the end of April, an additional lawsuit was filed arguing that Missouri's *"Parental Consent and Notice Requirement violates the Right to Reproductive Freedom because it denies, delays, penalizes, and otherwise restricts young people's ability to have an abortion."* So, while the Amendment 3 campaign told Missourians their initiative was about protecting *"patients," "doctors" and "families,"* **their attorneys were already writing lawsuits to undermine the safety of women, the role of doctors, and the role of parents in a minor's abortion.**

What if the pro-abortion extremists target our state again?

The answer lies in Missouri, appropriately dubbed the *"Show Me State."* They will spend millions deceiving voters to pass a deceptive amendment and if they're successful they'll target every safeguard for women, claiming safeguards *"limit"* abortion.

We must stand firm against the extremists who are working to undermine our laws and protect the safety of women and babies in our state.
